**ORDER DECLARING 11<sup>th</sup> ANNUAL  
GREATER PORTLAND FESTIVAL OF NATIONS  
IN DEERING OAKS PARK**

**ORDERED**, that Women in Need Industries, Inc./Mugadi Foundation is authorized to use Deering Oaks Park on Sunday, July 28, 2013 from 11:00 a.m. – 7:00 p.m. to hold their 11<sup>th</sup> annual free event to the public for music, food, cultural exhibits, children's activities, and folk art from many nations around the world; and

**BE IT FURTHER ORDERED**, that the festival area will also be closed to street vendors pursuant to Section 19-17 of the Portland City Code and is reserved for the use of Women in Need Industries, Inc. for the purpose of conducting the festival, subject to the direction and control of the City Manager; and

**BE IT FURTHER ORDERED**, that the main road into Deering Oaks Park will be closed to traffic at approximately 8:00 a.m. on July 28, 2013; and

**BE IT FURTHER ORDERED**, that the City Manager is authorized to issue a revocable permit under Section 25-27 of the Portland City Code subject to the following conditions:

- (1) Women in Need Industries, Inc./Mugadi Foundation shall defend, indemnify and hold the City harmless from and against all claims arising out of activities during said event, and shall take out and maintain public liability insurance coverage in the amount of at least \$400,000 combined single limit for personal or bodily injury, death, or property damage for said purposes. This insurance certificate will also list the City of Portland as an additional insured in regard to the Festival of Nations activities, and said indemnification and insurance provision shall also be provided in regard to hanging the banner over Congress Street; and
- (2) Under no circumstances may alcoholic beverages be sold or consumed on the streets or public property of said area during said festival; and
- (3) The following fees and expenses shall be waived by the City and in-kind contributions made by the City to the Festival:

Public Services: permit fees for use of grounds, banner fees, electricity fee,

Staff at setup of festival and festival itself, barricades, trash barrels and removal of trash;

Inspection Services: Tent permit, Inspector on day of event.

No Police or EMS, assistance should be necessary (Unless the Police Department deems coverage is necessary due to attendance, traffic concerns, etc. If police assistance is necessary, Women in Need Industries/Mugadi Foundation is responsible for covering those costs).

- (4) Conditions for use of grounds, specified in a permit issued from Public Services Event Office, shall be adhered to;
- (5) Festival of Nations shall leave on file with Public Services, security deposits for use of the park;
- (6) Festival of Nations/Women in Need Industries, Inc./Mugadi Foundation shall have sole authority over participating vendors at the event and may charge a fee to vendors for the opportunity to vend at the Festival of Nations; and

**BE IT FURTHER ORDERED**, that the City Manager is also authorized to issue such other temporary licenses, including licenses for food service establishments, as may be required by the Portland City Code, provided that all other applicable requirements of said code have been met regarding the operation of this event.
