INSPECTOR NOTES: **REPEAT** ICE MACHINE HAS BIOFILM INSIDE HEAD UNIT.

INSPECTOR NOTES: **REPEAT** MEATBALLS PLACED IN DEEP COVERED CONTAINER WERE 77F- 90F. PIC PLACED ON SHEET PAN TO COOL.

INSPECTOR NOTES: BACK DOOR HAS LARGE GAP.

INSPECTOR NOTES: PIZZA PAN RACKS ARE VERY GREASY.

54: 6-202.11: N: Lights not shielded.

INSPECTOR NOTES: NEED TO REPLACE BROKEN LIGHT SHEILDS IN KITCHEN.

INSPECTOR NOTES: NEED TO REPLACE BURNT OUT LIGHT BULBS IN KITCHEN AND INSTALL ADDITIONAL LIGHTING IN THE WALKIN.

Violation Correction Timeframe:

Critical violations should be corrected on site, but in any event, within 10 days. The licensee must contact the inspector when a violation has been addressed at 874-8772. Non-critical violations must be corrected within 30 days. Failure to satisfactorily correct these violations before the follow-up inspection may result in enforcement proceedings by the Department to include fines and penalties. License renewals can be denied if violations are not corrected within the noted timeframes.

C= Critical violation and NC= Non-critical violation:

“ Critical violation” means a provision of the Food Code that, if in non-compliance, is more likely than other violations to contribute to food contamination, illness or environmental health hazard.

Additional Inspection Fee:

License fees provide for two inspections per year. When additional inspections are required, the Department may charge an additional \$100 fee to cover the costs of each additional inspection or visit.

Document Retention/Posting:

Pursuant to the Maine Food Code, the establishment's current license must be displayed. In addition, a sign or placard must be posted in a conspicuous area notifying consumers that a copy of the most recent inspection report is available upon request. CFPM certificates must be posted in a conspicuous area and must be available to the Department upon request.
