SODEXO @ USM PORTLAND- WOODBURY COMMONS HAS VOLUNTARILY CLOSED FOR AN IHH DUE TO AN EXTENDED ELECTRICAL POWER OUTAGE. THE POWER WAS TURNED OFF BECAUSE OF A BROKEN SPRINKLER WATER MAIN IN THE BUILDING. NO WATER DAMAGE IN THE KITCHEN, DINING AREA, STORAGE AREAS, OR WALK-IN COOLER. ALL PHF IN THE WALK-IN COOLER AND FREEZERS WAS ABLE TO BE SALVAGED, TAKEN TO USM GORHAM CAMPUS IN COOLERS AND BELOW 41F BEFORE TRAVEL. ALL PHF FOODS IN LINE REACH-INS AND SELF-SERVICE COOLERS WAS DISCARDED DUE TO TEMPERATURE ISSUES. ALL SHELF-STABLE (DRY GOODS) FOOD ITEMS ARE OKAY TO USE. SODEXO @ USM PORTLAND- WOODBURY IS TO REMAIN CLOSED UNTIL THE HEALTH INSPECTOR RETURNS FOR A FOLLOW-UP INSPECTION.

Violation Correction Timeframe:

Critical violations should be corrected on site, but in any event, within 10 days. The licensee must contact the inspector when the critical violation has been addressed at 207-756-8016. Non-critical violations must be corrected within 30 days. Failure to satisfactorily correct these violations before the follow-up inspection may result in enforcement proceedings by the Department to include fines and penalties. License renewals can be denied if violations are not corrected within the noted timeframes.

C= Critical violation and NC= Non-critical violation:

“Critical violation” means a provision of the Food Code that, if in non-compliance, is more likely than other violations to contribute to food contamination, illness or environmental health hazard.

Additional Inspection Fee:

License fees provide for two inspections per year. When additional inspections are required, the Department may charge an additional \$100 fee to cover the costs of each additional inspection or visit.

Document Retention/Posting:

Pursuant to the Maine Food Code, the establishment's current license must be displayed. In addition, a sign or placard must be posted in a conspicuous area notifying consumers that a copy of the most recent inspection report is available upon request. CFPM certificates must be posted in a conspicuous area and must be available to the Department upon request.
