

## Inspection Notes

THIS IS A PARTIAL FOLLOW-UP INSPECTION TO CHECK ON THE ICE MACHINE THAT WAS PLACED OUT OF SERVICE DUE TO HEAVY BIOFILM IN THE ICE MAKER ON 5/9/19.

PIC STATED THAT THE MACHINE WAS NOT USED UNTIL THEY SELF-CLEANED THE MACHINE IN THE AFTERNOON AND DISCARDED THE ICE. INSPECTOR WAS NOT CONTACTED FOR FOLLOW UP INSPECTION. THE ICE MAKER HAS BEEN WIPED OUT BUT STILL NEEDS A PROFESSIONAL TO DISMANTLE AND CLEAN & SANITIZE THE MACHINE.

\*\*THE ICE MACHINE HAS BEEN PLACED ON HOLD UNTIL PROFESSIONLY CLEANED AND SANITIZED,ALL ICE IS DISCARDED AND INSPECTOR HAS CONDUCTED A FOLLOW UP INSPECTION. HOLD TAG #00318

Failure to satisfactorily correct these violations before the follow-up inspection may result in enforcement proceedings by the Department to include fines and penalties. License renewals can be denied if violations are not corrected within the noted timeframes.

C= Critical violation and NC= Non-critical violation:

“ Critical violation” means a provision of the Food Code that, if in non-compliance, is more likely than other violations to contribute to food contamination, illness or environmental health hazard.

**Additional Inspection Fee:**

License fees provide for two inspections per year. When additional inspections are required, the Department may charge an additional \$100 fee to cover the costs of each additional inspection or visit.

**Document Retention/Posting:**

Pursuant to the Maine Food Code, the establishment' s current license must be displayed. In addition, a sign or placard must be posted in a conspicuous area notifying consumers that a copy of the most recent inspection report is available upon request. CFPM certificates must be posted in a conspicuous area and must be available to the Department upon request.
