



License renewals can be denied if violations are not corrected within the noted timeframes.

“Critical violation” means a provision of the Food Code that, if in non-compliance, is more likely than other violations to contribute to food contamination, illness or environmental health hazard.


### Additional Inspection Fee:

### Document Retention/Posting:


