

45: 4-101.11.(A): C: Material used in construction of utensils or food contact surfaces of equipment is not safe.

INSPECTOR NOTES: *REPEAT* NEED TO REPLACE NON FOOD GRADE CONTAINERS WITH FOOD GRADE CONTAINERS (NSF), DISCUSSED AGAIN.

52: 5-501.115: N: Refuse areas and enclosures not maintained free of unnecessary items or not kept clean.

INSPECTOR NOTES: *REPEAT* NEED TO CLEAN DUMPSTER AREA OF ALL TRASH AND GREASE, DISCUSSED AGAIN.

53: 6-101.11.(A): N: Indoor surfaces are not properly constructed as to be smooth, durable, and easily cleanable or constructed of nonabsorbent material in areas of moisture.

INSPECTOR NOTES: *REPEAT* NEED TO REPLACE MISSING AND BROKEN FLOOR TILES IN THE FIRST FLOOR BAR, FLOOR NEEDS TO BE SMOOTH AND EASILY CLEANABLE.

53: 6-501.114: N: The premises is littered / unnecessary equipment and articles present.

INSPECTOR NOTES: *REPEAT* BASEMENT STORAGE AREAS ARE STILL CLUTTERED WITH EQUIPMENT AND UNNECESSARY ITEMS, NEEDS TO BE CLEANED AND ORGANIZED, DISCUSSED AGAIN.

53: 6-501.12: N: The physical facilities are not clean.

INSPECTOR NOTES: *REPEAT* KITCHEN FLOOR UNDER LINE EQUIPMENT NEEDS TO BE CLEANED, STILL HEAVY GREASE AND FOOD DEBRIS BUILDUP, DISCUSSED AGAIN.

2013 Maine Food Code Adoption

The Maine Food Code was adopted in October of 2013. Please refer to our website for a copy, <http://www.maine.gov/healthinspection>. Following are a few of the major changes:

- * No Bare Hand Contact with Ready-To-Eat Food. Handlers are required to use gloves, utensils, deli papers, etc., to avoid bare hand contact with ready-to-eat food;
- * Establishments must have clean-up procedures for employees to follow following vomiting and diarrheal events;
- * Responsibilities of the person in charge for ill employees (exclusions and restrictions); and,
- * Date marking of Ready-to-eat potentially hazardous foods.

Violation Correction Timeframe

Critical violations should be corrected on site, but in any event, within 10 days. The licensee must contact the inspector when the critical violation has been addressed at 207- 874-8365 or email ecobb@portlandmaine.gov. Non-critical violations must be corrected within 30 days. Failure to satisfactorily correct these violations before the follow-up inspection may result in enforcement proceedings by the Department to include fines and penalties, which are outlined in Sections 7, 8 and 9 of the Rules Relating to the Administration and Enforcement of Establishments Licensed by the Health Inspection Program available at <http://www.maine.gov/healthinspection>. License renewals can be denied if violations are not corrected within the noted timeframes.

C= Critical violation and NC= Non-critical violation

“Critical violation” means a provision of the Food Code that, if in non-compliance, is more likely than other violations to contribute to food contamination, illness or environmental health hazard.

Additional Inspection Fee

License fees provide for two inspections per year. When additional inspections are required, the Department may charge an additional \$100 fee to cover the costs of each additional inspection or visit.

Document Retention/Posting

Pursuant to the Maine Food Code, the establishment’s current license must be displayed. In addition, a sign or placard must be posted in a conspicuous area notifying consumers that a copy of the most recent inspection report is available upon request. CFPM certificates must be posted in a conspicuous area and must be available to the Department upon request.
